Why Your Volunteer Security Team Needs Protection

Sanctuaries are Vulnerable. Historically, sanctuaries have been vulnerable to violent attacks, from bombings at Black churches in the Civil Rights era to more recent shootings.

HOUSE OF WORSHIP VOLUNTEER SECURITY PLAN

\$275 Annually/Per Member

Corporate Single Payer Plan for Entire Teams

The ideal plan for Houses of Worship looking for a single payer option to provide coverage for members of a Volunteer Security Team when in service to the congregation.

The House of Worship VST Plan covers Volunteer Security Team members for any criminal, civil or administrative legal action stemming from a self-defense incident, an incident in defense of others while acting as a Volunteer Security Team Member at the Designated House of Worship, or at an official House of Worship Event.

Plan Includes Upgraded Coverage for Each VST Member:

- \$1,000,000 Bond Coverage
- \$1,000,000 Civil Liability

Plus Coverage of Up To:

- \$3,000 for Licensed Counseling
- \$4,000 in Crime Scene Cleanup

Requirements:

- Plan must be purchased by the House of Worship as a single payer with a minimum of 3 team members
- Only Volunteer Members of a House of Worship Security Team are eligible for benefits of the plan
- No coverage will be provided for any individuals compensated to provide security services to the organization
- Volunteers must be legally allowed to carry a firearm in the state and local area of service
- It is the sole responsibility of the Volunteer Team Member to understand and comply with carry laws/regulations in their area

Exclusions:

The VST Plan does NOT provide coverage to the Member for incidents outside of their House of Worship VST responsibilities. A VST member may purchase a separate individual plan from CCW Safe for protection in their time away from the House of Worship.
